Plan

- Define steps that allow the early adopter, "Shadow IT-er", to utilize the new service as soon as possible to avoid them going off on their own for the same service
- Involve the user in the planning so that they are aware when the new service can be available
- Incorporate a migration plan for the existing services to the new internalized services to minimize impact or adoption by the end user






